3. If there is any upward revision in the Offer Price/Offer Size at any time prior to the commencement of the last one (1) working day before the date of commencement of the tendering period or in the case of withdrawal of offer pursuant to Regulation 23 of the SEBI (SAST) Regulations, the same would be informed within two (2) working days by way of the Public Announcement in the same newspapers in which the original Detailed Public Statement dated October 31, 2025 in relation to this Offer had appeared. Such revision in the Offer Price would be payable for all the shares validly tendered anytime during the period that the offer is open and accepted under the Offer.
4. **There is no competitive bid.**
5. Shareholders, who have accepted the Offer by tendering the requisite documents in terms of the Public Announcement/ Detailed Public Statement/ Letter of Offer, shall not be entitled to withdraw such acceptance during the tendering period.

**Risk Factors relating to the transaction, the proposed offer and probable risks involved in associating with the Acquirers: -**

The risk factors set forth below pertains to the underlying transaction, i.e. this Open Offer and are not intended to be a complete analysis of all risks in relation to this Open Offer or in association with the Acquirers or the Target Company, but are only indicative. The risk factors set forth below do not relate to the present or future business or operations of the Target Company and any other related matters. These are neither exhaustive nor intended to constitute a complete analysis of the risks involved in participation or otherwise by an equity shareholder in this Open Offer, but are merely indicative. Equity shareholders are advised to consult their stock brokers, tax advisors and/ or investment advisors/ consultants, for analyzing all the risks with respect to their participation in this Open Offer.

**Relating to the Open Offer**

1. The Open Offer involves an Offer to acquire 26.00% of the total paid-up equity and voting share capital of CFL from the eligible persons at an Offer Price of Rs. 12/- (Rupees Twelve Only) per equity share. As on the date of this Letter of Offer, the closing market price of the Target Company is Rs. 46/- (Rupees Forty- Six Only) per equity share.
2. In the event that either (a) a regulatory approval is not received in a timely manner, (b) there is any litigation leading to stay on the Offer, then the Offer process may be delayed beyond the schedule of activities indicated in this Letter of Offer. Consequently, the payment of consideration to the equity shareholders of shares that have been accepted in the Offer as well as the return of shares not accepted by the Acquirers may be delayed. In case of the delay, due to non-receipt of statutory approvals, that may be required by the Acquirers as per Regulation 18(11) of the SEBI (SAST) Regulations, SEBI may, if satisfied that the non-receipt of such statutory approvals was not due to willful default or negligence or failure on the part of the Acquirers to diligently pursue such approvals, grant an extension for the purpose of completion of the Offer subject to the Acquirers agreeing to pay interest to the shareholders for the delay at the rate of ten percent per annum (10% P.A.) in terms of Regulation 18 (11) and (11A) of the SEBI (SAST) Regulations, 2011. Further, if delay occurs on account of willful default by the Acquirers in obtaining the requisite approvals, Regulation

17(9) of the SEBI (SAST) Regulations will also become applicable and the amount lying in the Escrow Account shall become liable to forfeiture. There may be a circumstance wherein SEBI may issue such instructions to the Acquirers to not proceed with the Offer and then it would not lead to delay but to withdrawal of the Offer.

3. Shareholders should note that the shareholders who have tendered their equity shares in acceptance of the Open Offer shall not be entitled to withdraw such acceptance during the tendering period even if the acceptance of equity shares under the Offer and dispatch of consideration gets delayed.
4. In compliance with SEBI Master Circular SEBI/HO/CFD/PoD-1/P/CIR/2023/31 dated February 16, 2023; a lien will be marked in the depository system by the Depositories against the equity shares tendered in the Offer. Upon finalization of the entitlement, only accepted quantity of equity shares will be debited from the demat account of the shareholders and the lien marked against the unaccepted equity shares will be released. It is understood that the Shareholders will be solely responsible for their decisions regarding their participation in this Offer.
5. In accordance with the Share Purchase Agreement, the acquisition of the Sale Shares shall be completed upon the fulfilment of conditions agreed between the Acquirers and the Sellers. Further in terms of Regulation 23(1) of the SEBI (SAST) Regulations, the Acquirers shall have the right to withdraw the Open Offer, in the event any statutory or other approvals specified in paragraph 7.10 (Statutory and Other Approvals) of the LOF or those which become applicable prior to completion of the Open Offer are finally refused. The following conditions under which the Acquirers can withdraw the Open Offer, as provided in Regulation 23(1) of the SEBI (SAST) Regulations are:
  - a) statutory approvals required for the open offer or for effecting the acquisitions attracting the obligation to make an Open Offer under these regulations having been finally refused, subject to such requirements for approval having been specifically disclosed in the detailed public statement and the letter of offer;
  - b) the Acquirer, being a natural person, has died;
  - c) any condition stipulated in the agreement for acquisition attracting the obligation to make the open offer is not met for reasons outside the reasonable control of the Acquirers and such agreement is rescinded, subject to such conditions having been specifically disclosed in the detailed public statement and the letter of offer; or

Provided that the Acquirers shall not withdraw an Open Offer pursuant to a public announcement made under clause (g) of sub-regulation (2) of Regulation 13, even if the proposed acquisition through the preferential issue is not successful.

The Acquirers intend to acquire 15,89,471 (Fifteen Lakhs Eighty-Nine Thousand Four Hundred and Seventy-One) equity shares of face value of Rs.10/- each representing 26.00% of total paid-up equity and voting share capital of the Target Company at an Offer Price of Rs. 12/- (Rupees Twelve Only) per equity share, payable in cash under the SEBI (SAST) Regulations. CFL does not have any partly paid-up equity shares as on the date of PA. Post this Offer, assuming full acceptance, the Acquirers will have significant equity ownership, effective management control and will be the Promoters of the Target Company pursuant to Regulations 3(1) & 4 of the SEBI (SAST) Regulations.
7. The Acquirers make no assurance with respect to the market price of the equity shares during the Offer Period and upon the completion of the Offer and disclaims any responsibility with respect to any decision by the shareholders on whether or not to participate in the Offer. The Acquirers make no assurance with respect to the financial performance of the Target Company.
8. The Acquirers and the Manager to the Offer accept no responsibility for the statements made otherwise than in the Public Announcement, Detailed Public Statement or this Letter of Offer or in the advertisement or any materials issued by or at the instance of the Acquirers and the Manager to the Offer and any person placing reliance on any other source of information would be doing so at its own risk.
9. The Acquirers do not accept the responsibility with respect to information contained in the Public Announcement or Detailed Public Statement or Letter of Offer that pertains to the Target Company and have been compiled from publicly available sources.
10. For the purpose of disclosures in the Public Announcement or Detailed Public Statement or this Letter of Offer in relation the Target Company and/or the Sellers, the Acquirers, the Manager to the Offer have relied on the information published by the Target Company and/or the Sellers, as the case may be, or publicly available sources and have not independently verified the accuracy of details of the Target Company and/or the Sellers. The Acquirers and the Manager to the Offer do not accept any responsibility with respect to any misstatement by the Target Company and/or the Sellers in relation to such information.

11. There are no actions taken, directions subsisting or pending proceedings against the Target Company including its Promoters and Directors excluding the details as stated herein below:

**a. Unascertained and Contingent Liability under Good and Service Tax:**

Certain proceedings have been initiated by the GST authorities in relation to GST Input Tax Credit aggregating to approximately Rs. 96 Lakhs. The Company has challenged the said proceedings before the appropriate appellate authority and the matter is presently pending adjudication.

The amount involved represents an uncrystallized exposure arising out of an ongoing statutory proceeding. The outcome of the matter is not ascertainable at this stage. The Company shall keep BSE Limited informed of any material development in this regard.

**b. Uncrystallized Contingent Liability under Income Tax:**

The Company has received a Show Cause Notice under Section 263 of the Income Tax Act, 1961 from the Office of the Principal Commissioner of Income Tax, Surat, in respect of certain transactions aggregating to approximately Rs. 126.47 Lakhs.

The said transactions were earlier examined by the Assessment Unit, Surat and were disposed of by issuance of a NIL Demand Notice under Section 156 of the Act on March 21, 2023. Subsequent proceedings have been initiated under Section 263 of the Act, which are presently under challenge before the appropriate authority.

The amount involved represents an uncrystallized exposure arising from the aforesaid proceedings and is pending adjudication. Any material development in the matter shall be duly intimated to BSE Limited.

12. The risk factors set forth above pertain to the acquisition and the Offer and is not related to the present or future business operations of the Target Company or other related matters, and are neither exhaustive nor intended to constitute a complete analysis of the risks involved in participation or otherwise by a shareholder in the Offer. Shareholders of the Target Company are advised to consult their stockbroker or investment consultant, if any, for further risk with respect to their respective participation in the Offer.

### 3. DETAILS OF THE OFFER:

#### 3.1. Background of the Offer:

- 3.1.1 The Acquirers have entered into SPA dated October 24, 2025 with the Sellers of the Target Company, to acquire from them in aggregate 41,88,549 (Forty-One Lakhs Eighty-Eight Thousand Five Hundred and Forty-Nine) equity shares (“**Sale Shares**”) of face value of Rs. 10/- each representing 68.51% of the total paid-up equity and voting share capital of the Target Company at a price of Rs. 10/- (Rupees Ten Only) per equity share, payable in cash (“**Negotiated Price**”) for an aggregate consideration of Rs. 4,18,85,490/- (Rupees Four Crores Eighteen Lakhs Eighty-Five Thousand Four Hundred and Ninety Only). Pursuant to acquisition of the aforesaid equity shares in terms of the SPA, the aggregate shareholding of the Acquirers in the Target Company would exceed the threshold limit as prescribed under Regulation 3(1) of the SEBI (SAST) Regulations; accordingly, this mandatory Offer is being made under Regulation 3(1) of the SEBI (SAST) Regulations. Further, in terms of the SPA and post successful completion of the Open Offer, the Acquirers will also acquire control over the Target Company and hence this mandatory Offer is also being made under Regulation 4 of the SEBI (SAST) Regulations. The negotiated price of Rs. 10/- (Rupees Ten Only) per fully paid-up equity share has been mutually agreed upon by the Acquirers and the Sellers pursuant to bona fide discussions and negotiations.
- 3.1.2 The prime object of the Offer is to comply with the applicable requirements of the SEBI (SAST) Regulations with respect to the substantial acquisition of shares/voting rights accompanied with the change in control and management of the Target Company subject to receipt of all statutory approvals required in this Open Offer.
- 3.1.3 The Acquirers are making this mandatory Open Offer under the provisions of Regulations 3(1) and 4 of the SEBI (SAST) Regulations to acquire upto 15,89,471 (Fifteen Lakhs Eighty-Nine Thousand Four Hundred and Seventy-One) equity shares of face value of Rs. 10/- each representing 26.00% of total paid-up equity and voting share capital of the Target Company at a price of Rs. 12/- (Rupees Twelve Only) per equity share (“**Offer Price**”) payable in cash, aggregating to Rs. 1,90,73,652/- (Rupees One Crore Ninety Lakhs Seventy-Three Thousand Six Hundred and Fifty-Two Only) (“**Offer Size**”), subject to the terms and conditions mentioned hereinafter. Assuming that the Open Offer is tendered in full, after the completion of this Open Offer, the Acquirers shall hold the majority of the Equity Shares of the Target Company by virtue of which they shall become the Promoters of the Target Company and shall be in a position to exercise effective management and control over the Target Company.
- 3.1.4 The Acquirers have not acquired any equity shares/ voting rights of CFL during the fifty- two (52) weeks period immediately preceding the date of the Public Announcement except for acquisition of 41,88,549 equity shares acquired pursuant to execution of the Share Purchase Agreement between the Acquirers and the Sellers. Pursuant to the consummation of the SPA on December 09, 2025 in accordance with Regulation 22(2) of the SEBI (SAST) Regulations, the Acquirers have collectively acquired 41,88,549 Equity Shares held by the Sellers, representing 68.51% of the total paid-up equity and voting share capital of the Target Company at a negotiated price of Rs. 10/- per Equity Share, aggregating to Rs. 4,18,85,490/- (Rupees Four Crores Eighteen Lakhs Eighty-Five Thousand Four Hundred and Ninety Only). In this regard, the Acquirers have duly complied the provisions specified under Regulation 18(6) of the SEBI (SAST) Regulations.
- 3.1.5 There is no Person Acting in Concert (“**PAC**”) with the Acquirers for the purpose of this Open Offer in terms of Regulation 2(1)(q)(2) of the SEBI (SAST) Regulations.
- 3.1.6 The payment of consideration shall be made in cash to all the equity shareholders, who have tendered their equity shares in acceptance of the Open Offer, within ten working days of the expiry of the Tendering Period.
- 3.1.7 Subject to satisfaction of the provisions under the Companies Act, 2013 and/ or any other applicable Rules/ Regulation(s), the Acquirers intend to make changes in the management of the Target Company.
- 3.1.8 The Acquirers have keen interest in the business of the Target Company and to venture the business opportunities the Acquirers intend to acquire the majority stake in the Target Company and over the control and management of the Target Company. The Acquirers propose to continue existing business of the Target Company and may diversify its business activities in future with prior approval(s) of the shareholders of the Target Company and such statutory and/or regulatory authority, as may be applicable, in due compliance with applicable laws. The main purpose of takeover is to expand the Company’s business activities in same/ diversified line through exercising effective control over the Target Company. However, no firm decision in this regard has been taken or proposed so far.

#### 3.1.9 The Salient features of the transaction triggering the Open Offer are as under:

- a) The Sellers collectively hold 41,88,549 equity shares of the Target Company aggregating to 68.51% of the total paid-up equity and voting share capital of the Target Company as detailed herein below:

- b) The Sellers have agreed to sell and the Acquirers have agreed to acquire in aggregate 41,88,549 equity shares representing 68.51% of the total paid-up equity and voting share capital of the Target Company at a price of Rs. 10/- (Rupees Ten Only) per share in cash for an aggregate consideration of Rs. 4,18,85,490/- (Rupees Four Crores Eighteen Lakhs Eighty-Five Thousand Four Hundred and Ninety Only). [**“Purchase Price”**].
- c) As on the date of this LOF, there is no lien, encumbrance on the Sale Shares held by the Sellers of the Target Company.
- d) The Sellers undertake that in case the Acquirers so desire, they shall immediately facilitate to appoint them or their nominees on the Board of Directors of the Target Company in terms of Proviso to Regulation 24(1) read with Regulation 17 of the SEBI (SAST) Regulations and also transfer the shares in the demat account of the Acquirers as mentioned in the SPA in terms of compliance of Regulations 22(2) and 24(1) of the SEBI (SAST) Regulations. Accordingly, they have transferred the shares to Acquirers on December 09, 2025 in accordance with the SEBI (SAST) Regulations

- 3.1.14 The Acquirers are desirous of acquiring majority shareholding in the Target Company along with acquiring the management and control in the Target Company. Therefore, the Acquirers have entered into SPA with all the Promoters of the Target Company, thereby triggering this mandatory Open Offer in compliance with Regulations 3(1) & 4 of the SEBI (SAST) Regulations. Upon the completion of the Offer, assuming full acceptance in the Offer and equity shares acquired pursuant to the aforesaid acquisition which triggered the Open Offer, the Acquirers will hold 57,78,020 (Fifty-Seven Lakhs Seventy-Eight Thousand and Twenty) equity shares leading to a change in management and control and be construed as the Promoters of the Target Company.
- 3.1.15 The Manager to the Offer, VC Corporate Advisors Private Limited, do not hold any equity shares in the Target Company as on the date of DPS or this Letter of Offer. The Manager to the Offer further declares and undertakes that they will not deal on their own account in the equity shares of the Target Company during the Offer Period.
- 3.1.16 The Acquirers undertake that they will not sell the equity shares of the Target Company held by them during the Offer period, if any, in terms of Regulation 25(4) of the SEBI (SAST) Regulations.
- 3.1.17 The Acquirers have not been prohibited by SEBI from dealing in the securities, in terms of directions issued under Section 11B of SEBI Act, 1992 as amended or under any other Regulations made under the SEBI Act. Further, there are no proceedings pending against the under the Acquirers under the SEBI Act.
- 3.1.18 The Acquirers have deposited Rs. 1,96,00,000/- (Rupees One Crore Ninety-Six Lakhs Only) in Cash in the Escrow Account under Regulation 17 of the SEBI (SAST) Regulations, which is more than the entire consideration payable under the Offer, assuming full acceptance of the Offer. Pursuant to Regulation 22 of SEBI (SAST) Regulations and other applicable regulations, the Acquirers have, after the expiry of twenty-one working days from the date of Detailed Public Statement, acted upon the SPA and completed the acquisition of 41,88,549 Equity Shares held by the Sellers, representing 68.51% of the total paid-up equity and voting share capital of the Target Company on December 09, 2025 and acquired management control over the Target Company.
- 3.1.19 In compliance with Regulation 24(1) read with Regulation 17 of the SEBI (SAST) Regulations, as more than entire consideration is deposited in the Escrow Account, the Acquirers may reconstitute the Board of Directors of the Target Company by appointing themselves or person(s) representing them on the Board of Directors of the Target Company. As on the date, the Acquirers have not decided on the names of persons who may be appointed on the Board of Directors of the Target Company.
- 3.1.20 As per Regulation 38 of the SEBI (LODR) Regulations read with Rule 19(2) and 19A of the Securities Contract (Regulation) Rules, 1957 as amended (“SCRR”) the Target Company is required to maintain at least 25.00% public shareholding (“**Minimum Public Shareholding**”), as determined in accordance with SCRR, on continuous basis for listing. Upon completion of the transaction, if the public shareholding of the Target Company falls below the minimum level of public shareholding as required to be maintained by the Target Company as per the SCRR and the SEBI (LODR) Regulations, the Acquirers hereby undertake to take necessary steps to facilitate the compliance by the Target Company with the relevant provisions prescribed under the SCRR as per the requirements of Regulation 7(4) of the SEBI (SAST) Regulations and/or the SEBI (LODR) Regulations, within the time period stated therein, i.e., to bring down the non-public shareholding to 75% within 12 months from the date of such fall in the public shareholding to below 25.00%, through permitted routes and any other routes as may be approved by SEBI from time to time. Further, any failure to comply with MPS requirement may lead to non-compliance of SCRR and SEBI (LODR) Regulations.
- 3.1.21 As per Regulation 26(6) of the SEBI (SAST) Regulations, the Board of Directors are required to constitute a committee of Independent Directors to provide reasoned recommendations on this Offer to the equity shareholders. Such recommendations of the committee of Independent Directors of the Target Company on the Offer will be published at least two (2) working days before the commencement of the tendering period, in the same newspapers where the DPS was published and a copy of the same shall be sent to SEBI, BSE and Manager to the Offer in compliance with Regulation 26(7) of the SEBI (SAST) Regulations.

## 3.2. Details of the proposed Offer:

- 3.2.1 The Detailed Public Statement pursuant to the Public Announcement made by the Acquirers have appeared in the Financial Express (English Daily) all editions, Jansatta (Hindi Daily) all editions, Prataskal (Marathi daily) Mumbai edition and Ahmedabad express (Gujrati daily) Surat edition on October 31, 2025 in compliance with Regulation 14(3) of the SEBI (SAST) Regulations. The Detailed Public Statement made on October 31, 2025 is available on the websites of SEBI and Stock Exchange at [www.sebi.gov.in](http://www.sebi.gov.in) and [www.bseindia.com](http://www.bseindia.com), respectively.

- 3.2.2 The Acquirers are making this mandatory Open Offer under the provisions of Regulations 3(1) and 4 of the SEBI (SAST) Regulations to acquire upto 15,89,471 (Fifteen Lakhs Eighty-Nine Thousand Four Hundred and Seventy-One) equity shares of face value of Rs.10/- each representing 26.00% of total paid-up equity and voting share capital of the Target Company, at a price of Rs. 12/- (Rupees Twelve Only) per equity share (the “**Offer Price**”) payable in cash, aggregating to Rs. 1,90,73,652/- (Rupees One Crore Ninety Lakhs Seventy-Three Thousand Six Hundred and Fifty-Two Only) (“**Offer Size**”), subject to the terms and conditions mentioned hereinafter.
- 3.2.3 This Open Offer is being made to all the public shareholders of the Target Company as on Wednesday, January 28, 2026 (“**Identified Date**”), except parties to the Share Purchase Agreement.
- 3.2.4 The Acquirers have deposited 100% of the consideration payable, assuming full acceptance, in cash, in the Escrow Account and after the expiry of 21 (Twenty-One) working days from the date of the DPS they have acted upon the Agreement and have completed the acquisition of 41,88,549 Equity Shares representing 68.51% of the total paid-up equity and voting share capital of the Target Company pursuant to the consummation of Underlying Transaction under the SPA on December 09, 2025 at a negotiated price of Rs. 10/- per Equity Share in compliance with Regulation 22(2) of SEBI (SAST) Regulations and acquired control over the Target Company as contemplated under Regulation 22(2) of the SEBI (SAST) Regulations. Thus, as on the date of LOF, the Acquirers collectively hold 41,88,549 Equity Shares representing 68.51% of the total paid-up equity and voting share capital of the Target Company.
- 3.2.5 The Sellers undertake that in case the Acquirers so desire, they shall immediately facilitate to appoint them or their nominees on the Board of Directors of the Target Company only after depositing 100% of the consideration payable, assuming full acceptance, in cash, in the Escrow Account in terms of Proviso to Regulation 24(1) read with Regulation 17 of the SEBI (SAST) Regulations. However, the Acquirers have not decided on the names of persons who may be appointed on the Board of Directors of the Target Company till date.
- 3.2.6 The payment of consideration shall be made in cash, in accordance with Regulation 9(1)(a) of the SEBI (SAST) Regulations, to all the equity shareholders, who have tendered their equity shares in acceptance of the Open Offer, within ten working days of the expiry of the Tendering Period.
- 3.2.7 As on date of this LOF, the Target Company does not have partly paid-up equity shares. There are no outstanding warrants or option or similar instrument, convertible into equity shares at a later stage.
- 3.2.8 The Offer is subject to receipt of statutory approval of the SEBI of this Letter of Offer. If any other statutory approval becomes applicable prior to the completion of the Offer, this Offer would also be subject to such other statutory approval(s).
- 3.2.9 This Offer is not pursuant to any global acquisition resulting in an indirect acquisition of equity shares of the Target Company.
- 3.2.10 This Offer is not conditional upon any minimum level of acceptance in terms of the Regulation 19(1) of the SEBI (SAST) Regulations and not a Competitive Bid in terms of the Regulation 20 the SEBI (SAST) Regulations.
- 3.2.11 There is no differential pricing for equity shares under the Offer.
- 3.2.12 Since the date of PA to the date of this LOF, the Acquirers have acquired 41,88,549 Equity Shares representing 68.51% of the total paid-up equity and voting share capital of the Target Company pursuant to the consummation of Underlying Transaction under the SPA on December 09, 2025 at a negotiated price of Rs. 10/- per Equity Share in compliance with Regulation 22(2) of SEBI (SAST) Regulations and control over the Target Company and the same have been informed by them on December 09, 2025 to BSE, CFL and Manger to the Offer.
- 3.2.13 No competitive bid has been received as on date of this LOF.
- 3.2.14 There are no conditions as stipulated in the SPA, the meeting of which would be outside the reasonable control of the Acquirers and in view of which the Offer might be withdrawn under Regulation 23(1) of the SEBI (SAST) Regulations.
- 3.2.15 Upon the completion of the Offer, assuming full acceptance in the Offer and equity shares acquired pursuant to the aforesaid acquisitions which triggered Open Offer, the Acquirers will hold 57,78,020 (Fifty-Seven Lakhs Seventy-Eight Thousand and Twenty) equity shares representing 94.51% of the total paid-up equity and voting share capital of the Target Company and hence there will be a change in the management and control pursuant to this Open Offer. Accordingly, the Acquirers will be inducted as the Promoters of the Target Company post completion of the Open Offer in compliance with the conditions specified under Regulation 31A of the SEBI (LODR) Regulations and other statutory approvals applicable thereto and all the Promoters will be reclassified into non-promoter category under Regulation 31A of the SEBI (LODR) Regulations. Pursuant to the aforementioned acquisition, the Target Company will be in violation of the requirement of Minimum Public Shareholding. As stated under the aforementioned para

3.1.20 the Acquirers would bring down their shareholding within the permissible limits. Further, any failure to comply with MPS requirement may lead to non-compliance of SCRR and SEBI (LODR) Regulations, 2015.

3.2.16 The Manager to the Offer, VC Corporate Advisors Private Limited, do not hold any equity shares in the Target Company as on the date of this LOF. The Manager to the Offer further declares and undertakes that they will not deal on their own account in the equity shares of the Target Company during the Offer Period.

### **3.3. Objects of the Offer:**

3.3.1 The primary objective of the Offer is substantial acquisition of shares and voting rights in the Target Company and subsequently acquire control over the Target Company in compliance with the SEBI (SAST) Regulations subject to receipt of all statutory approvals required in this Open Offer.

3.3.2 The Acquirers have joined hands to acquire the controlling stake in the Target Company to avail the benefits of a listed company giving them the presence in pan India along with reliability / credibility involved with a listed company. The Target Company is engaged in the business of trading in man-made art silk fabrics. However, the Target Company has not undertaken any operations since last 3 years. Tarun Jain, being one of the Acquirers of the Target Company possesses over twenty years of experience in the clothing and garments industry, primarily as a businessman. His expertise spans the entire spectrum of apparel and fashion and he is known for his entrepreneurial skills and deep understanding of garment business trends and challenges.

The other Acquirers possess qualities to enhance the business of the Target Company including sale like Mr. Sumit Bansal has expertise in goods trading, sales and marketing substantiated with over twelve years of industry experience. He specializes in strategic planning, business development, channel management, and relationship management, driving impactful sales and marketing initiatives across diverse sectors, Mr. Vikkas Bansal a seasoned businessman with over twenty-five years of extensive experience in the field of die casting industry and involvement in various other businesses and Mr. Varun Jindal is a Chartered Accountant equipped with financial expertise.

This ensures that the Acquirers possess the technical know-how and market understanding necessary to revive operations. By leveraging its financial strength, industry expertise, and proven managerial capabilities, the Acquirers aim to restructure the Target Company, introduce viable business activities, and thereby unlocking long-term value for the shareholders of the Target Company.

3.3.3 This Open Offer is for acquisition of 26.00% of total paid-up equity and voting share capital of the Target Company. Assuming that the Open Offer is tendered in full, after the completion of this Open Offer, the Acquirers shall hold the majority of the equity shares of the Target Company by virtue of which they shall be in a position to exercise effective management and control over the Target Company.

3.3.4 Subject to satisfaction of the provisions under the Companies Act, 2013 and/ or any other applicable Rules/ Regulation(s), the Acquirers intend to make changes in the management of the Target Company.

3.3.5 The Acquirers do not have any plans to dispose off or otherwise encumber any significant assets of CFL in the succeeding 2 (two) years from the date of closure of the Open Offer, except in the ordinary course of business of the Target Company and except to the extent required for the purpose of restructuring and/or rationalization of the business, assets, investments, liabilities or otherwise of the Target Company. In the event any substantial asset of the Target Company is to be sold, disposed off or otherwise encumbered other than in the ordinary course of business, the Acquirers undertake that they shall do so only upon the receipt of the prior approval of the shareholders of the Target Company through a special resolution in terms of Regulation 25(2) of SEBI (SAST) Regulations and subject to the provisions of applicable law as may be required. The Acquirers propose to continue the existing business of the Target Company and may diversify its business activities in future with prior approval(s) of the shareholders of the Target Company and such statutory and/or regulatory authority, as may be applicable, in due compliance with applicable laws. The main purpose of takeover is to expand the Company's business activities in same/diversified line through exercising effective control over the Target Company. However, no firm decision in this regard has been taken or proposed so far.

- e. Except as mentioned in point (d) above, Acquirer 4 does not hold directorship in any other listed or unlisted Company nor does he serve as a Whole-time Director in any Company.

#### **Other Confirmations:**

4.5. Acquirer 1, Acquirer 2, Acquirer 3 and Acquirer 4 are hereinafter collectively referred to as the Acquirers.

#### 4.6. **Relationship between the Acquirers:**

Acquirer 1 and Acquirer 2 are brothers. There is no relationship between Acquirer 3 and Acquirer 4 apart from having common objective for acquisition of shares and management control of the Target Company. Except as mentioned herein, there is no other existing relationship amongst the Acquirers.

#### 4.7. **Experience of the Acquirers with business of Target Company:**

Tarun Jain, being one of the Acquirers of the Target Company possess over twenty years of experience in the clothing and garments industry, primarily as a businessman. His expertise spans the entire spectrum of apparel and fashion and he is known for his entrepreneurial skills and deep understanding of garment business trends and challenges. The other Acquirers possess qualities to enhance the business of the Target Company including sale, like Mr. Sumit Bansal has expertise in goods trading, sales and marketing substantiated with over twelve years of industry experience, Mr. Vikas Bansal is a seasoned businessman with over twenty-five years of extensive experience in the field of die casting industry and involvement in various other businesses and Mr. Varun Jindal is a Chartered Accountant equipped with necessary financial expertise.

4.8. There are no Person Acting in Concert (“PAC”)/ Deemed PACs with the Acquirers for the purpose of this Open Offer in accordance with provisions of regulation 2(1)(q)(2) of the SEBI (SAST) Regulations.

4.9. As stated above, the Acquirers do not have any other relationship &/or interest in the Target Company including with its Directors, Promoters & key employees. There are no persons on the Board of the Target Company representing the Acquirers as director on the Board of the Target Company. The Acquirers do not belong to any Group. The Acquirers do not have any kind of direct or indirect relation with the public shareholders of the Target Company. There are no actions taken or pending proceedings against the Acquirers.

- 4.10. In the past, the Acquirers were not required to undertake any compliance under the applicable provisions of Chapter V of SEBI (SAST) Regulations in respect to acquisition / disposal of equity shares in the Target Company. The details of compliances under Chapter V of the SEBI (SAST) Regulations with respect to acquisition of 41,88,549 equity shares by the Acquirers on December 09, 2025, under the SPA dated October 24, 2025 are mentioned under para 5.18 of this LOF.
- 4.11. As on the date of this LOF, the Acquirers have not been prohibited by the SEBI from dealing in the securities, in terms of direction issued under Section 11B of SEBI Act, 1992 as amended or under any other Regulations made under the SEBI Act.
- 4.12. As on the date of this LOF, the Acquirers have not been categorised as fugitive economic offenders under Section 12 of the Fugitive Economic Offenders Act, 2018 read with Regulation 2(1)(ja) of the SEBI (SAST) Regulations.
- 4.13. As on the date of this LOF, the Acquirers have not been categorized or are appearing in the 'Willful Defaulter or a Fraudulent Borrower' list issued by any bank, financial institution, or consortium thereof in accordance with the guidelines on willful defaulters or fraudulent borrowers issued by the Reserve Bank of India read with Regulation 2(1)(ze) of the SEBI (SAST) Regulations.
- 4.14. The Acquirers undertake that they will not sell the equity shares of the Target Company, held and acquired by them, during the Offer Period in terms of Regulation 25(4) of the SEBI (SAST) Regulations.
- 4.15. The Acquirers hereby undertake that if they will acquire any equity shares of the Target Company during the Offer Period, then they will inform BSE, the Target Company and the Manager to the Offer within 24 hours of the acquisition in compliance with Regulation 18(6) of the SEBI (SAST) Regulations. Further, they also undertake that they will not acquire or sell any equity shares of the Target Company during the period between three working days prior to the commencement of the Tendering Period and until the closure of the Tendering Period as per Regulation 18(6) of the SEBI (SAST) Regulations.
- 4.16. The Acquirers do not have any intention to delist the equity shares of the Target Company pursuant to this Open Offer.
- 4.17. As on date of this LOF, the Acquirers have already acquired control pursuant to acquisition of 68.51% of the total paid-up equity and voting share capital of the Target Company, however, they have not appointed any nominee on the Board of Directors of the Target Company.
- 4.18. There are no penalties levied against the Acquirers by the SEBI/ Stock Exchange or any other Regulator.

## 5. BACKGROUND OF THE TARGET COMPANY:

*(Information relating to the Target Company has been obtained from information available in public domain and neither the Acquirers nor the Manager to the Offer has independently verified the same)*

- 5.1. Classic Filaments Limited ("**CFL**" / "**Target Company**") was incorporated as a Private Limited Company on April 24, 1990 under the Companies Act, 1956 in the name and style of "V. Natverlal Synthetics Private Limited" with the Registrar of Companies ("**ROC**"), Gujarat. Subsequently, the name of the Target Company was changed to "Classic Filaments Private Limited" and a fresh certificate of Incorporation consequent upon change of name was issued on September 10, 1993. The company has subsequently been converted into a Public Limited Company and a fresh certificate from ROC, Gujarat, Dadra & Nagar Haveli has been obtained on February 15, 1995. There has been no change in the name of the Target Company in the last three years. The Registered Office of CFL is presently situated at Plot No. 1, Priyanka House, Umiyadham Road, Varachha, Surat- 395006. The CIN of CFL is L17114GJ1990PLC013667, Tel No.: 0261-2540570 and Email: [classicfilaments@ymail.com](mailto:classicfilaments@ymail.com). There has been no change in the registered office of the Company since the completion of the previous Open Offer triggered through SPA dated September 05, 2023 to till date. The Target Company has not been shown as a part of Promoter / Promoter Group of any listed entity.
- 5.2. The Company came out with a Public Issue in the year 1995 and its equity shares got listed on Ahmedabad Stock Exchange Limited, Vadodara Stock Exchange Limited and BSE in 1996. Subsequently, due to failure to comply with the listing requirements, the BSE compulsorily delisted the equity shares of the Target Company on April 20, 2004. However, the equity shares continued to remain listed on Ahmedabad Stock Exchange Limited and Vadodara Stock Exchange Limited. Thereafter, the Vadodara Stock Exchange Limited was derecognized by SEBI vide its order dated November 09, 2015 with immediate effect. Later on, the Target Company got its Equity Shares listed on BSE Limited, under the Direct Listing process on February 22, 2017 and continued to remain listed on the Ahmedabad Stock Exchange Limited also. Subsequently, the Ahmedabad Stock Exchange Limited was also derecognized by SEBI vide its order dated April 02, 2018 with immediate effect. Since then, the Equity Shares of the Target Company are exclusively listed on BSE Limited only and the equity shares of the Target Company have never been suspended from trading on BSE Limited to till date.

- 5.3. The Authorised Share Capital of CFL is Rs. 7,50,00,000/- divided into 75,00,000 Equity Shares of the face value Rs. 10/- each. The Issued, Subscribed & Paid-up Equity Share Capital of the CFL is Rs. 6,11,33,500/- comprising of 61,13,350 equity shares of face value Rs. 10/- each. CFL has established its connectivity with both the depositories namely National Securities Depositories Limited (“NSDL”) and Central Depository Services (India) Limited (“CDSL”). The ISIN of CFL is INE181U01018 & the marketable lot for equity share is 1 (One) equity share.
- 5.4. The Target Company is engaged in the business of trading in man-made art silk fabrics. The textile sector was severely affected by prolonged uncertainty, repeated disruptions, and reduced market demand during and after the COVID-19 period. As a result, many textile businesses, including that of the Target Company, were temporarily suspended. Further, the Target Company’s GST registration was cancelled during this period due to pending disputes, originating prior to the year 2021, relating to input GST credit amounting to ₹24 Lakhs, along with prolonged operational inactivity. The GST registration was subsequently restored by the GST authorities in October, 2024. Although the Target Company had duly paid its own GST liabilities in the normal course of business prior to the cancellation, disputes arose in relation to input GST credit, which are currently pending in appeal before the competent authority. Due to the above factors, no operational activities generating revenue were undertaken since last 3 years. However, the Target Company has continued to comply with all applicable statutory requirements and has incurred only minimal administrative and establishment expenses.
- 5.5. As on the date of this LOF, the Target Company does not have any partly paid- up equity shares. There are no outstanding warrants or options or similar instruments, convertible into equity shares at a later stage. No equity shares have been pledged by the Acquirers, Promoters and Public shareholders of Target Company.
- 5.6. As on the date of this LOF, the Target Company including its Promoters, Directors and Key Managerial Personnels have not been categorised as Fugitive Economic Offenders under Section 12 of the Fugitive Economic Offenders Act, 2018 read with Regulation 2(1)(ja) of the SEBI (SAST) Regulations and Wilful Defaulters under Regulation 2(1)(ze) of the SEBI (SAST) Regulations.
- 5.7. The Promoters or Directors of the Target Company do not have any direct or indirect connection/ relation with the public shareholders of the Target Company.
- 5.8. In accordance with Regulation 31A(10) of the SEBI LODR Regulations, the Promoters have given their respective intent letters to reclassify them from Promoter’s Category to Non-Promoter’s Category.
- 5.9. The entire equity shares of CFL are presently listed at BSE only. The equity shares of CFL are infrequently traded on the BSE within the definition of “frequently traded shares” under Regulation 2(1)(j) of the SEBI (SAST) Regulations.
- 5.10. The equity share capital of the Target Company is as follows:

- 5.12. There has been no merger / demerger or spin off involving CFL during the last 3 years.
- 5.13. There are no actions taken, directions subsisting or pending proceedings against the Target Company including its Promoters and Directors excluding the details as stated herein below:

**a. Unascertained and Contingent Liability under Good and Service Tax:**

Certain proceedings have been initiated by the GST authorities in relation to GST Input Tax Credit aggregating to approximately Rs. 96 Lakhs. The Company has challenged the said proceedings before the appropriate appellate authority and the matter is presently pending adjudication.

The amount involved represents an uncrystallized exposure arising out of an ongoing statutory proceeding. The outcome of the matter is not ascertainable at this stage. The Company shall keep BSE Limited informed of any material development in this regard.

**b. Uncrystallized Contingent Liability under Income Tax:**

The Company has received a Show Cause Notice under Section 263 of the Income Tax Act, 1961 from the Office of the Principal Commissioner of Income Tax, Surat, in respect of certain transactions aggregating to approximately Rs. 126.47 Lakhs.

The said transactions were earlier examined by the Assessment Unit, Surat and were disposed of by issuance of a NIL Demand Notice under Section 156 of the Act on March 21, 2023. Subsequent proceedings have been initiated under Section 263 of the Act, which are presently under challenge before the appropriate authority.

The amount involved represents an uncrystallized exposure arising from the aforesaid proceedings and is pending adjudication. Any material development in the matter shall be duly intimated to BSE Limited.

5.14. From the date of the PA to till date there are no directions or pending proceedings against the Manager to the Offer and Registrar to the Offer (including their Directors) under SEBI Act, 1992, as amended or by any other Regulator. Further, there have been no penalties levied against them by the SEBI/ RBI/ Stock Exchanges or by any other Regulator from the date of PA to till date.

Eligible persons can participate in the Offer by offering their shareholding in whole or in part. No indemnity is required from the unregistered owners.
- 7.4 Accidental omission to dispatch this LOF or the non-receipt or delayed receipt of this LOF will not invalidate the Offer in anyway.

- 8.6 The facility for Acquisition of shares through Stock exchange Mechanism pursuant to an Open Offer shall be available on the BSE in the form of Separate Window ("**Acquisition Window**").

- 8.8 As per the provisions of Regulation 40(1) of the SEBI (LODR) Regulations and SEBI's press release dated December 03, 2018 bearing reference number PR 49/ 2018, requests for transfer of securities shall not be processed unless the securities in dematerialised form with a depository w.e.f. April 01, 2019. However, in accordance with SEBI circular bearing reference number SEBI/HO/CFD/CMD1/CIR/P/2020/144 dated July 31, 2020, shareholders holding securities in physical form are allowed to tender shares in an Open Offer. Such tendering shall be as per the provisions of the SEBI (SAST) Regulations. Accordingly, Public Shareholders holding equity shares in physical form as well are eligible to tender their equity shares in this Offer as per the provisions of the SEBI (SAST) Regulations.
- 8.9 All the equity shareholders who desire to tender their equity shares under the Open Offer will have to intimate their respective stock brokers ("**Selling Brokers**" or "**Seller Member**") within the normal trading hours of the Secondary Market, during the Tendering period.

**8.14 Procedure for tendering shares held in Dematerialized Form.**

- a) The equity shareholders who are holding the equity shares in demat form and who desire to tender their equity shares in this Offer shall approach their broker indicating to their broker the details of equity shares they intend to tender in Open Offer.
- b) Under the existing mechanism, the shares tendered by the shareholders, on its acceptance will be directly transferred to the account maintained by the Clearing Corporation.
- c) As per SEBI Master Circular SEBI/HO/CFD/PoD-1/P/CIR/2023/31 dated February 16, 2023, a lien shall be marked against the shares of the shareholders participating in the tender offers. Upon finalization of the entitlement, only accepted quantity of shares shall be debited from the demat account of the shareholders. The lien marked against unaccepted shares shall be released.

Alternatively in case of non-receipt of this Letter of Offer, shareholders holding shares may participate in the Offer by providing their application in plain paper in writing signed by all shareholder, stating name, address, number of shares held, client Id number, DP name, DP ID number, number of shares tendered and other relevant documents such as physical share certificates and Form SH-4 in case of shares being held in physical form. Such Shareholders have to ensure that their order is entered in the electronic platform to be made available by the BSE before the closure of the Offer.

8.19 No indemnity is needed from the unregistered shareholders.

8.20 Non-receipt of this Letter of Offer by, or accidental omission to dispatch this Letter of Offer to any shareholder, does not invalidate the Offer in any way.

8.21 The acceptance of the Offer made by the Acquirers is entirely at the discretion of the shareholders of the Target Company. The Acquirers do not accept any responsibility for the decision of any shareholder to either participate or to not participate in this Offer. The Acquirers will not be responsible in any manner for any loss of share certificate(s) and other documents during transit and the shareholders are advised to adequately safeguard their interest in this regard.

#### **8.22 Acceptance of Equity Shares**

Registrar to the Offer shall provide details of order acceptance to Clearing Corporation within specified timelines. In the event that the number of equity shares (including demat equity shares, physical equity shares and locked-in equity shares) validly tendered by the Shareholders under this Offer is more than the number of Offer Shares, the Acquirers shall accept those equity shares validly tendered by the Shareholders on a proportionate basis in consultation with the Manager, taking care to ensure that the basis of acceptance is decided in a fair and equitable manner and does not result in non-marketable lots, provided that acquisition of equity shares from a shareholder shall not be less than the minimum marketable lot.

## 8.23 Settlement Process

- a. On closure of the Offer, reconciliation for acceptances shall be conducted by the Manager to the Offer and the Registrar to the Offer and the final list shall be provided to the Stock Exchange to facilitate settlement on the basis of shares transferred to the Clearing Corporation. The settlement of trades shall be carried out in the manner similar to settlement of trades in the secondary market. Selling Brokers should use the settlement number to be provided by the Clearing Corporation to transfer the shares in favor of Clearing Corporation.
- b. The shares shall be directly credited to the pool account or client account(s) of the Buying Broker. For the same, the existing facility of client direct pay-out in the capital market segment shall be available. Once the basis of acceptance is finalized, the Clearing Corporation would facilitate clearing and settlement of trades by transferring the required number of shares to the pool account of the Buying Broker. In case of partial or non-acceptance of orders or excess pay-in, demat Shares shall be released to the securities pool account of the Selling Broker / custodian, post which, the Selling Broker would then issue contract note for the shares accepted and return the balance shares to the Shareholders. Any excess physical equity shares, to the extent tendered but not accepted, will be returned to the Shareholder(s) directly by Registrar to the Offer.

## 8.24 Settlement of Funds/ Payment Consideration

The settlement of fund obligation for demats and physical equity shares shall be affected through existing settlement accounts of Selling Broker. The payment will be made to the Buying Broker for settlement. For equity shares accepted under the Open Offer, the Selling Broker/ Custodian Participant will receive funds payout in their settlement bank account. The Selling Brokers/ Custodian participants would pay the consideration to their respective clients. The funds received from Buying Broker by the Clearing Corporation will be released to the Selling Broker(s) as per secondary market pay-out mechanism. Shareholders who intend to participate in the Offer should consult their respective Selling Broker for payment to them of any cost, charges and expenses (including brokerage) that may be levied by the Selling Broker upon the selling Shareholders for tendering equity shares in the Offer (secondary market transaction). The consideration received by the selling Shareholders from their respective Selling Broker, in respect of accepted equity shares, could be net of such costs, charges and expenses (including brokerage) and the Acquirers accept no responsibility to bear or pay such additional cost, charges and expenses (including brokerage) incurred solely by the selling Shareholder. In case of delay in receipt of any statutory approval(s), SEBI has the power to grant extension of time to Acquirers for payment of consideration to the shareholders of the Target Company who have accepted the Open Offer within such period, subject to Acquirers agreeing to pay interest for the delayed period if directed by the SEBI in terms of Regulation 18 (11) and (11A) of the SEBI (SAST) Regulations.

## 9. NOTES ON TAXATION

- 9.1. The basis of charge of Indian income-tax depends upon the residential status of the taxpayer during a tax year. The Indian tax year runs from April 1 until March 31. A person who is an Indian tax resident is liable to income-tax in India on his worldwide income, subject to certain tax exemptions, which are provided under the Income Tax Act, 1961. A person who is treated as a non-resident for Indian income-tax purposes is generally subject to tax in India only on such person's India sourced income (i.e. income which accrues or arises or deemed to accrue or arise in India) or income received or deemed to be received by such persons in India. In case of shares of a company, the source of income from shares would depend on the 'Situs' of such shares. 'Situs' of the shares is generally where a company is 'incorporated'. Accordingly, since the Target Company is incorporated in India, the Target Company's shares should be deemed to be 'situated' in India and any gains arising to a non-resident on transfer of such shares should be taxable in India under the Income Tax Act, 1961 ("IT Act").
- 9.2. Gains arising from the transfer of shares may be treated either as 'capital gains' or as 'business income' for income-tax purposes, depending upon whether such shares were held as a capital asset or business asset (i.e. stock-in-trade). The IT Act also provides for different income-tax regimes/ rates applicable to the gains arising from the tendering of equity shares under the Open Offer, based on the period of holding, residential status, classification of the shareholder and nature of the income earned, etc. Any applicable surcharge and education cess would be in addition to such applicable tax rates.
- 9.3. Based on the provisions of the IT Act, the shareholders would be required to file an annual income-tax return, as may be applicable to different category of persons, with the Indian income tax authorities, reporting their income for the relevant year. The summary of income-tax implications on tendering of equity shares on the recognized stock exchange and chargeable to Securities Transaction Tax ("STT") is set out below.
- 9.4. Taxability of capital gain in the hands of the equity shareholders:
  - i. The Finance Act, 2024, vide Section 112A, has imposed an income tax on long-term capital gains at the rate of 12.50% (Twelve and half percent only) (On or after July 23, 2024) on transfer of equity shares that are listed on a recognized stock exchange, which have been held for more than 1 (one) year and have been subject to STT upon both acquisition and sale (subject to certain transactions, yet to be notified, to which the provisions of applicability of payment of STT upon acquisition shall not be applicable). Under this provision the capital gains tax would be calculated on gains exceeding ₹1,25,000/- (Rupees One Lakh and Twenty-Five Thousand Only) (without any

indexation and foreign exchange fluctuation benefits). It may also be noted that any capital gains arising up to January 31, 2018 are grandfathered under this provision. The cost of acquisition for the long-term capital asset acquired on or before January 31, 2018, will be the actual cost. However, if the actual cost is less than the fair market value of such asset (lower of consideration on transfer) as on January 31, 2018, the fair market value will be deemed to be the cost of acquisition.

- ii. As per section 111A of the IT Act, short-term capital gains arising from transfer of listed shares on which STT is paid would be subject to tax at the rate of 20% (Twenty percent only) for equity shareholders (except certain specific categories).
- iii. Any applicable surcharge and education cess would be in addition to above applicable rates.
- iv. In case of resident equity shareholders, in absence of any specific provision under the IT Act, the Acquirers shall not deduct tax on the consideration payable to resident equity shareholders pursuant to the Offer. However, in case of non-resident equity shareholders, since the Offer is through the recognized stock exchange, the responsibility to discharge the tax due on the gains (if any) is on the non-resident equity shareholders. It is therefore recommended that the non-resident equity shareholder may consult their custodians/authorized dealer's/ tax advisors appropriately.
- v. The tax implications are based on provisions of the IT Act as applicable as on date of this LOF. In case of any amendment made effective prior to the date of closure of this Offer, then the provisions of the IT Act as amended would apply.
- vi. Notwithstanding the details given above, all payments will be made to the equity shareholders subject to compliance with prevailing tax laws. The final tax liability of the equity shareholder shall remain of such equity shareholder and the said equity shareholder will appropriately disclose the amounts received by it, pursuant to this Offer, before the Indian income tax authorities.
